# 1. Project Summary

Social Enterprise Exchange (SEE) is a comprehensive programme of social enterprise support contributing to jobs, growth and social inclusion across the Sheffield City Region (SCR). It is delivered by a community-based consortium in collaboration with Sheffield City Region Growth Hub and is part funded by the European Regional Development Fund 2014 - 2020

Social Enterprise Exchange will promote social entrepreneurship, through awareness raising events, knowledge exchange and peer networking; it will provide support for start-ups, including hot-desks, start-up grants and mentoring; and it will offer specialist enterprise support for existing social enterprises to grow and to develop new products and services.

Within the Social Enterprise Exchange programme, Sheffield Live! is responsible for promotional activities and for marketing and communications support to clients. As part of this work we are now seeking to recruit a freelance journalist with an interest in business and social enterprise to join the Sheffield Live news team. The person appointed will be responsible for collecting social enterprise case stories and for reporting on topical issues relating to business and social enterprise for both broadcast and online publication.

# 2. Specific objectives of the Social Enterprise Reporter

- A. To record, edit and produce a minimum of 72x video case stories of 4 minutes in length highlighting the work of selected social enterprises in Sheffield City Region.
- B. To record, edit and produce a minimum of 176x video news reports of 3-5 minutes in length on topical issues relating to business and social enterprise in Sheffield City Region.

## 3. Duration and targets

The contract is for a total duration of 22 months with time allocated and targets as follows:

Months 1 - 6 (60 days)

4 days per month on video news stories, delivering at least 8 stories per month 6 days per month on video case stories, delivering at least 6 case stories per month

Months 7 - 18 (84 days)

4 days per month on video news stories, delivering at least 8 stories per month 3 days per month on video case stories, delivering at least 3 case stories per month

Months 19 – 22 (16 days)

4 days per month on video news stories, delivering at least 8 stories per month

#### 4. Contract value

The contract is based on a fixed day rate of £100 (inclusive of all taxes and holidays) amounting to a total value of £16,000 subject to meeting performance targets.

Subject to requirements and available budget the contract may be further increased by up to a maximum of 50% based on the same fixed day rate and pro rata targets.

Reasonable expenses will be paid for travel to and from assignments.

Contract for the work will commence May 2017 and end March 2019.

### 5. Selection criteria

All tenders will be required to demonstrate that they sufficiently meet the following gateway selection criteria to demonstrate their capability to deliver the services offered:

- (i) Previous experience and track record in video journalism
- (ii) Availability for the period May 2017 to March 2019
- (iii) Agreement to the fixed rate set for this contract
- (iv) Ability to provide a reference from at least two 2 previous clients

#### 6. Award criteria

Selected proposals will be awarded on the basis of Most Economically Advantageous Tender and responses will be evaluated using the criteria/weightings set out below.
